Umpire in Chief - Karen Richardson

No report. Umpire list will be sent out to Player Placement for team consideration so teams will not have multiple umpires on one team.

Managers' Representative – Fay Nickel

Fay is willing to continue doing the stats for the season. Fay will continue to be the Manager's Rep until the new managers vote in one for the 2026 year.

Batting Averages scale- there are two different scales in circulation. There is a five-point scale and a ten-point scale. The managers have agreed that the ten-point scale will be used for rating players. The question becomes what about the non-runners.

Old Business

Non-Runner rule concerns were discussed. The specifics that were decided include:

Players will determine at the beginning of the season if they want to be considered a DECLARED* non-runner knowing it is based on seniority, and let the Registrar or Team Selection chair know.

A designated non-runner will be decided at the beginning of the season for each team. Teams that are not assigned a DECLARED* non-runner must decide preseason, if they will assign the designation as a non-runner for the season, to a specific player that agrees to be the nonrunner OR if they will choose to not have a non-runner for the season. The designation will be reported out to all managers for the season.

The last player out on each team is the runner for the non-runner.

New Business

Sheila- per Sue Rabbage: Arlene Johnson, field two. Sue will make a presentation of the signage on Opening Day.

Connie suggested a ribbon cutting ceremony on the Arlene Johnson field.

Connie- ASA to USSSA or SPA rule changes for women. We will look into this.

Rita- CanAm game name change suggestion- include the word international to include all active players.

Sandy- The language on Women's Player Placement document dated, November 2022 needs some cleanup for clarity, including amending the date. The board will review constitution as well as, other documents and send suggestions for the 2026 playing year to Rules Committee to present and discuss at the next board meeting.
