#### **SPECIAL Business : Equipment-Bats**

There has been some discussion and some concerns about the playing rules and constitutional language regarding some bats being used in the league. This is specific to Vexxum bats that are two piece, that contain composite materials.

Karen R., Umpire in Chief of the women's league, explained the bat approval process. She explained who checks the bats and the required criteria of the bats used for league play at Citrus Park. Karen listed the current bat approvers in the league. It was suggested that to keep bats and their approval up to date, different colored stickers be used from year to year.

There was review of the wording about bats, under special equipment, in the constitution and our playing rules.

There was further discussion that the playing rules for the men and women are different.

She introduced wording with regards to altered equipment and the concern about bat warmers being used.

It was decided that the women's playing rules would not change until further review and possible direction and decision from the League Board.

The list of banquet Invitations needs to be thoroughly reviewed and sent out to all past presidents. There may have been a communication error and a former president did not receive an invite to last year's banquet.

The Women's Section Rules, Women's Playing Rules and the League Constitution were reviewed by Rita and Connie, the Rules Committee. Approved board changes have been posted on the CP Softball website. The non-running rule has been reinstated. All members are encouraged to read and review the rules for the 2026 season.

### **Past President – Connie Hill**

Discussed the requirements of being a President on the board and the required time commitment of three years.

She also informed the membership of the progress she is making on the banquet with regards to caterer and entertainment.

There was discussion about the new spokesperson rule change. She presented the differentiation between being a base coach and spokesperson.

### **Ratings- Joanne Thomas**

Joanne stated that she is new to the position of Ratings Chair will be up for vote for the 2027 season. She announced her committee members and informed the membership that she will scheduling a session for two people in the near future.

End of Season Ratings from 2025 Season are those posted on the CP website. New players and those players that have been rerated to play in 2026 are not included in that posting.

As the Member at Large, Cindy also explained that she is responsible for sending out cards on behalf of the league. Please contact her if there is anything that should be recognized by the membership in celebration or remembrance.

#### **Umpire in Chief - Karen Richardson**

Karen reported that the last 10-15 years have been super. She will train anyone interested in umpiring this season. She also requested support for the umpire staff by our membership.

She reminded women their bats need an updated CP Softball sticker and need to be placed in the bat rack prior to game time for the umpires to review. She explained that there is no change in the current women's bat rules.

#### **Managers' Representative – Jody Henderson**

Jody stated that this is a new role and that Fay is a great help.

She introduced this year's managers: Kelly G., Becky M./Connie H., Kat F. Dora H./Shelley C. She explained that the duties of the managers are incredible and that these women are outstanding in their roles. As this is a daunting task at times we are encouraged to be supportive.

#### **Player Representative-Lois Droogsma**

Lois was introduced and the membership is encouraged to reach out and contact Lois if there are any problems or concerns that arise. These situations would be those that are sensitive for a team or within the league.

#### **New Business**
